### Contracts and Agreements

The Warren County R-III Board of Education approved contracts and agreements for:

- Great Circle for outside placement for students with special education needs.
- Special Education compliance plan with DESE.
- The acceptance of \$2,000 grant from the Missouri Afterschool Network.

### Old Business

Policy Approvals:

- *Policy KKB*: Audio and Visual Recording -- Students are no longer required to ask permission to record. If recordings materially or substantially interferes with the operation of the school then students can be disciplined.
- *Policy GBCA*: Staff Conflict of Interest -- Changes the nepotism policy from 4th degree to 2nd degree. Now allowing family members of the superintendent, assistant superintendent, or school board members to be newly hired in the district if they are in the 3rd or 4th degree. First or second degree of the superintendent, assistant superintendent, or school board members are still prohibited to be newly hired.
  - First Degree: Spouse, children, parents
  - Second Degree: Siblings, grandchildren, grandparents
- *Policy BBFA-2*: Board Member Conflict of Interest -- removes the duplicate language that is in policy GBCA.
- *Policy GCD*: Professional Staff Recruiting and Hiring -- removes the duplicate language that is in policy GBCA.
- *Policy ACA*: Sexual Harassment Under Title IX -- Changes the Title IX coordinator from Dr. Jones to Dr. Ross.

- Form AC-AF1: Prohibition Against Illegal Discrimination, Harassment and Retaliation -- Changes the Title IX coordinator from Dr. Jones to Dr. Ross.

## New Business

### *Breakfast/Lunch Prices*

- The federally funded universal free meals for all students has expired. Students who qualify for free or reduced meals will continue to receive free meals. Those that do not qualify for free meals will be required to purchase. Below is the pricing.
  - Grades K - 5
    - Breakfast = \$1.75
    - Lunch = \$2.75
  - Grades 6 - 12
    - Breakfast = \$1.75
    - Lunch = \$2.95
  - Faculty and Staff
    - Breakfast = \$2.50
    - Lunch = \$4.15

*Tuition Rate* -- The tuition rate for the 22-23 school year is set at \$11,108.52 per year.

*22-23 Bus Routes* -- The 22-23 bus routes were approved. [Here is a link to the routes.](#)

*Economic Development Council Invoice* -- The district continues to be a member of the Greater Warren County Economic Development Council at the \$1,000 contributor level.

*New Stipend Positions* -- Positions for Girls Wrestling Coach, Esports, and Future Teachers Club were approved.
