Contracts and Agreements

- A memorandum of understanding with Missouri Baptist University was approved. Staff of Warren County R-III are now eligible for reduced tuition cost for graduate courses. There is no cost to the district.
- A contract with Reading Eggs for Rebecca Boone was approved. The total cost is \$916.20.
- A contract with Lead School was approved to provide IEP services.

New Business2024-2025 Course Guides

The high school and middle school course guides were approved. New courses at the high school include Leadership Development - WHS Spirit, Registered Youth Apprenticeships, Expansion of Dual Credit, and Intro to the Bible. French as a stand alone course has been removed from the course guide. Students interested in French can still take it through our virtual program. New middle school courses include career education in 6th and 8th grade.

Bus Lease Agreement

An agreement to lease buses for early childhood special education through 2028 was approved for a total cost of \$470,373. This cost is 100% reimbursable from the state.

Geotechnical Test Borings and Surveying of District Property

Surveying and test borings for the property the district owns for the potential new elementary building was approved. Cochran Engineering will provide the survey and SCI engineering will provide the geotechnical test borings for a total cost of \$38,750.

Prop R3 Resolution

The Warren County R-III School Board passed an official resolution to place Prop R3 on the ballot for April 2, 2024.
