The Warren County R-III Board of Education approved contracts and agreements for:

Old Business

Policy Approvals

- JG-R Student Discipline The language regarding being disciplined for recording was removed from this policy as it is covered in policy KKB (audio and visual recordings).
- EBBC Lactation Support The district will now have dedicated space that will be used exclusively for lactation. This will put the district in compliance with a new state law.

22-23 Teacher Salary Schedule

There is no change to the previously approved teacher salary schedule. This salary schedule clearly identifies which steps will receive a combination of district funds and state grant money so the district can reach the minimum teacher salary of \$38,000. The grant money is pending the governor's signature.
