Contracts and Agreements

- The district entered into a contract with Youth In Need to continue to provide space in our elementary buildings for pre-k education.
- The district approved a change order on the food service facility to replace the soil under the parking lot for a total cost of \$6,930.
- The district approved contracts to provide maintenance to the elevator at Warrior Ridge and lift at Rebecca Boone were approved. The total cost is \$5,880 annually.
- The district approved eRate vendors to provide phone and internet services for the district. The district expense is \$34,751.98 annually.
- The district approved amended agreements with the State of Missouri for the district to receive subsides for Latchkey.

<u>22-23 Staffing Plan Amendment #2</u>

The amended staffing plan combines three open paraprofessional positions to a special education teacher position. This will provide support to a special education classroom at Daniel Boone.

New Business

Holy Rosary Cooperative Agreement

The district approved a cooperative agreement to participate with Holy Rosary for all middle school athletics for the 23-24 school year. If Holy Rosary is able to field a team in any sport, the district will cancel the cooperative agreement prior to the season for that sport and grade level.

Voluntary Benefits Provider

The district approved US Enrollment Services as our provider of voluntary benefits for staff. These voluntary benefits are paid completely by the individual staff member. The district shops providers to try and find the best pricing and best services for our staff. More information will be sent directly to staff members about this change.

Parents as Teachers Partnership with Wentzville School District

The district approved partnering with the Wentzville School District to help provide parents as teachers services to our community. The district has had staffing issues this year and has been unable to provide parents as teachers services. The Wentzville School District has agreed to help the district to provide these services. We are grateful to the Wentzville School District to help support our community in this manner.
