The Warren County R-III School District Board of Education holds its regular meetings in the Media Center of Warrenton High School on the second Thursday of every month at 7:30pm. Special meetings may be called when necessary.

By law, comments about specific individuals are limited to closed session only. The district is interested in hearing those comments in a setting that is both appropriate and legal. Comments about specific employees are best delivered to the supervisor of the employee first and allow them the opportunity to address the concerns.

If you wish to address the Board during tonight's meeting, please complete the bottom portion of this sheet and return it to the Board Secretary, prior to the start of the meeting. Patron comments will be appropriate only during open session.

Only the individual, or the individuals, who requested to address the Board by filling in the appropriate form prior to the meeting, will be allowed to speak. Members of the audience are not allowed to speak or to join in the discussion. No individual will be permitted to speak more than once during this period.

***Speakers may offer such objective criticisms of school operations and programs as concern them. The Board will not hear personal complaints of school personnel nor complaints against any person connected with the school district in public session. Other channels provide for Board consideration and disposition of legitimate complaints involving individuals. Discussions of personnel matters are scheduled for executive session.***

***The Board vests in its president the authority to terminate the remarks of individuals when not adhering to the rules established above.***

***Persons addressing the Board are advised that they should not expect a response from the Board at the time of their presentation.***
