DISTRICT REPORTS:

- Dr. Klinginsmith presented the August, 2020, Financial Report and the **Transportation Department Evaluation**, which was authored by Director of Transportation David Tinnin.
- Curriculum Coordinator Thea Etcher then presented the **2020-2021 Assessment Plan**.

CONTRACT AND SERVICE APPROVALS:

Contracts with Instructure, the City of Warrenton, an independent speech language therapist, an independent contractor to do vision assessments for students who are blind or partially sighted, Walgreens, Cipafilter, and Cintas.

NEW BUSINESS:

- Bus Routes for the 2020-2021 school year were approved, with the understanding that they are subject to change. The routes are available to be viewed **here**.
- Tuition for the 2020-2021 school year was set at \$9,722.06 per year.
- The board voted to again join the Greater Warren County Economic Development Council at the rate of \$1,000
- Kroencke Landscaping was approved as the district lawn service for the next three years.
- The board voted to suspend to the extent that any policy or procedure of this school district conflicts with new state and federal laws enacted relating to the COVID-19 pandemic or the waiver, suspension or amendment of an existing law or regulation made by the federal government, the Missouri Governor or state agencies in relation to the COVID-19 pandemic. This is a **recommendation from MSBA** that suspends any policies that are in conflict with state or federal regulation in relation to the COVID-19 pandemic.
- For the 2020-2021 school year, Care Days will have a fee of \$20 per day, \$10 for four hours or less of attendance, and will remain free for families who qualify for free or reduced lunch.
- The **Reopening Plan** for the 2020-2021 school year was approved
