### **Old Business**

The negotiated staff agreement was approved for the 2021-22 school year. The agreement includes giving all staff, excluding the superintendent, a step on the salary schedule. This is approximately a 2% raise for each individual. The agreement also includes increasing the base hourly wage for our food service employees, latchkey, workroom aides, and lunchroom monitors to the the 2022 minimum wage of \$11.15. The agreement also maintains the same level of insurance coverage at an additional cost of 6.4% of the current insurance cost. All additional costs are expected to be covered by additional revenue coming in for next year.

The board approved policy GCBDB which requires teachers who are on sabbatical to inform the district if they are planning on returning to work for the following school year by March 1st.
