### **COVID Protocols**

There are no changes to the district COVID protocols. The school district is now required to take action on the COVID Protocols every 21 days regardless if there are changes or not.

Policy BBB - School Board Elections - was approved. In the event the district does not have to hold an election, the new board members will assume the responsibilities of their office at the same time and same manner as if they had been elected.

# **New Business**

#### Food Service Facility


The board approved the construction of a new food service facility. This facility will be paid for out of food service funds. These funds can only be used for food service. Currently, the food service fund is at \$1,354,698 and the estimated building cost will be \$1,146,112. The district is required to spend down these funds to only have approximately three months of food service bills. The district has received additional revenue from the federal government due to all students being classified as free lunch students.

## Daniel Boone/ Middle School HVAC Bids

The board has approved new HVAC units for Daniel Boone Elementary and the Middle School for a total of \$1,496,000. These units will be paid for out of the federal COVID stimulus funds. Installation of these units should occur over the summer.

# Rebecca Boone/ Warrior Ridge Boundary Adjustment

Due to Warrior Ridge Elementary approaching capacity, the board of education approved the new subdivision being built at the corner of Warrior Avenue and Pinckney to be redistricted to Rebecca Boone Elementary. In the map below, the entire area highlighted in blue is what could potentially be developed. The entire development plus the section in white has been redistricted to Rebecca Boone. The district believes there is only one house currently in this zone and the redistricting should not change the boundary of any current elementary student.



# Holy Rosary Co-Op

The board of education has approved a cooperative sponsorship with Holy Rosary Catholic School and Black Hawk Middle School. Students attending Holy Rosary may now participate in Black Hawk Middle School's cross country, football, cheerleading, softball, track and field, and wrestling programs.

### **Budget Amendment #2**

A budget amendment was approved to reflect the actual funds received. The new projected revenue for the school year is \$45,532,702 and the projected expenditures are \$43,639,849.
