New Business

Bus Bids

The district will be leasing 3 type A buses and 3 type C buses for a total of \$125,382. These buses will be used for early childhood transportation. The lease of these buses is 100% reimbursable for early childhood special education.

The district will be purchasing 4 type C buses to be used in everyday transportation. The total cost of this \$580,812. This will be budgeted out of the capital projects budget for next school year.
