New Hires

Contracts and Agreements

The Warren County R-III Board of Education approved contracts and agreements for:

- City of Warrenton for crossing guards and school resource officers.
- City of Truesdale for crossing guards.
- Compass Health to provide additional mental health services to students.
- Rosemann Speech and Language Services to provide speech and language services for special education students during extended school year (ESY).

New Business

The school board approved Integra as to construct the "shell" of the food service facility for a total cost of \$569,423. This will be paid for out of food service funds.

The final budget amendment for the 21-22 school year was approved. The district ended the year with total revenue of \$45,461,955 and total expenditures of \$40,280,474.

Kroencke Landscaping was approved to repair the baseball field for a total of \$39,700.

Lactation Pods for the field house, transportation department, and the data center were approved for a total of \$47,850. Existing spaces in all other buildings are being converted to lactation rooms so the district will be in compliance with a new state law.

Pepsi-Cola was awarded the vending rights for the next 60 months.

New high school weight room equipment was approved for a total of \$94,991. This is the curriculum revision year for physical education. This will come out of the curriculum supply budget. This equipment will be used for during physical education courses during the day and for athletic conditioning outside of regular school hours.
