### Contracts and Agreements

- The district approved a contract with Canvas to download our assessment data onto district servers. The total cost is \$6,000.
- The district approved a contract with Innsbrook to host prom. The total cost is \$12,950.
- The district approved a star Math Assessment for Rebecca Boone. This will be paid for out of Rebecca Boone's budget for a total of \$1,197.
- The district approved a contract with Infinite Campus to replace a portion of Tyler Analytics. The total cost is \$7,406.
- The district approved a contract with Arbiter Sports to be consistent with other schools in the GAC conference so officials can be paid consistently. The total cost is \$1,500.

### Old Business

#### Policy Approval

Form AC-AF1 - *Prohibition Against Illegal Discrimination Harassment and Retaliation* - Updates language to comply with the U.S. Department of Agriculture for participation in the federal free/reduced lunch program.

Form BBB-AF2 - *School Board Elections* - Updates language to comply with new state law that requires school board candidates to have lived in the district for at least one year preceding their election.

Form BBE-AF2 - *School Board Vacancies* - Updates language to comply with new state law that requires school board candidates to have lived in the district for at least one year preceding their election.

Form BBF-AF1 - *School Board Ethics* - Simplifies language in the form.

Form DJF-AF3 - *Purchasing* - Updates language to match Administrative Procedure DJF-AP1

Form EF-AF1 - *Food Service Management* - Updates language to comply with the U.S. Department of Agriculture for participation in the federal free/reduced lunch program.

## New Business

### Intergovernmental Agreements

The district approved an agreement with the City of Warrenton to provide two additional School Resources Officers (SROs). The City of Warrenton will provide a total of four SROs to the school district. The school district will pay 2/3 of the cost of the SROs and the City of Warrenton will pay 1/3 the cost. These SROs will be stationed at Warrenton High School, Black Hawk Middle School, Warrior Ridge, and Daniel Boone.

The district approved an agreement with the City of Truesdale to provide one School Resource Officer at Rebecca Boone. The school district will pay 1/2 of the cost of the SRO and the City of Truesdale will pay for 1/2 the cost.

### Naming of Early Childhood Center

The Early Childhood Special Education Center name is now changed to Hopewell Academy Early Childhood Center.
