New Business


A contract with Diligent was approved. BoardDocs has been acquired by Diligent. BoardDocs will be phased out of over the course of this school year and Diligent will replace BoardDocs.


A contract with Infinite Campus was approved. Tyler Technology is discontinuing SISK12 (the district's student information system). Infinite Campus will replace SISK12 for the 23-24 school year. SISK12 will continue to be used for the remainder of this school year. The total cost for Infinite Campus is \$53,577.

An amendment to the staffing plan was approved to reduce one paraprofessional position in the district and add a workroom aide position at Rebecca Boone.

Adjustments to the Elementary Boundaries were approved. This only impacts future developments. No current residences are impacted by these adjustments. The adjustments move new developments into the Daniel Boone attendance center. Below are the adjustments.
