
Below is information from the September 9, 2021 Warren County R-III School Board meeting.

Old Business

Policy Approval

Policies related to making Juneteenth a holiday were approved.

Policies related to staff compensation and salary schedule changes were approved.

Policy BBFA - Board Member Conflict of Interest and Financial Disclosure as required by the Missouri Ethics Commission was approved.

COVID Protocols

All schools excluding early childhood are now included in the 1% threshold for a mask mandate. This includes the high school. Tomorrow, Friday September 10th, the high school will be above 1% threshold and will be required to wear masks. Due to the timing of this notification, enforcement of this rule will not begin until Tuesday.

Students can now return to school before the quarantine end date with a doctor's note. The note from the doctor must say the student is no longer contagious. This is in accordance with state regulation (19 CSR 20-20.040). Here is a direct link to the regulation. Please see page 8 #2a. NOTE: Students are not allowed to participate in MSHSAA events if they come back earlier than the quarantine date set by our local health department. MSHSAA only supports what is approved by our local health department and this early return from quarantine plan is not approved by our local health department.

The deadline to enroll in virtual courses has been extended to September 17th.

New Business

The annual secretaries board report (ASBR) was approved. The final operational fund balance for the 20-21 school year was 20.79%

Sarah Janes, Franci Schwartz, and Jeff Schneider will serve on the district comprehensive school improvement plan (CSIP) team. The first meeting will now be in October.
